
The PLN 2,509 million increase in turnover of Taxonomy-eligible activities compared to 2023 is primarily attributable to changes in the following segments:

- Distribution – an increase in average tariff rates compared to 2023
- Railway Energy Services – inclusion of the full-year value for 2024, whereas in the previous year, only nine months were accounted for; the Railway Energy Services segment was acquired in the second quarter of 2023
- Gas-fired Generation – recognition of revenue following the commencement of operational activities by PGE Gryfino Dolna Odra sp. z o.o.

Within the segments, Taxonomy-aligned activities were identified, generating a total turnover of PLN 14,996 million. The majority related to the following activities:

- CCM 4.9 Transmission and distribution of electricity under: Distribution and Railway Energy Services
- CCM 4.3 Electricity generation from wind power under Renewables
- CCM 6.14 Infrastructure for rail transport under Railway Energy Services




